- f. Einschulung The Verein appreciates the recognition for helping fund the 2nd graders tie-dye t-shirts (and the school shop made 400 Euros that day)
- g. Haus Reil renovation is moving along, slowly but surely. The Verein has just transferred close to 20.000 Euros, our pledge to furnish Haus Reil.
- h. Verein Events No Fun Run nor Meet and Treat, but if all the stars align, we will organize a community event. The Board will get together and brainstorm soon. Fun Day is scheduled for next fall
- i. Vison/Goal for the year working towards digitalizing of memberships/cancellations/files and signing up more members especially in ES

6. Report from the Treasurer – Robert Erlbaum

- a. The new bank account is up and running. The old bank account will remain active until such time that it is deemed ready for closure.
- b. The Verein is now looking for a new tax advisor as the previous tax advisor has declined to provide service due to shortages of personnel.
 - If any Verein member knows of an available tax advisor, they are encouraged to provide contact information to treasurer@theverein.com.
- c. In light of this year's push to digitize all elements of the Verein work, the Executive Committee has reviewed and determined that an App for all members would serve as the best method for communication, managing membership status, organizing events, and general organization of Verein activities. This app, Tuurio, is locally based in Berlin, thereby following GDPR requirements for data security and as well the developer is available for contact.
 - A motion is made by the Treasurer to the Board for vote on pursuing this App further for widespread use among Verein Members.
 - The motion passes with 12 yes votes.
- d. In many organizations which manage financial and other important responsibilities, there is normally an insurance coverage established to cover any unfortunate situations, whether caused by the existing board or a previous

board. This is referred to as a "Directors and Officers Insurance", or D+O for short.

The estimated cost for such an insurance is currently around €1.800.

The Treasurer makes a motion to the Board to acquire such an insurance to cover the board for any unforeseen or unfortunate circumstances.

The motion passes with a vote of 12 yes votes.

e. Question to the Administration: Would it be possible to establish a Wifi (or WLAN) connection to be made available for use by the Verein during monthly Board meetings on campus.

MF: Yes. I will look into this. There should at least be the possibility to provide a Wifi extension to what already exists for the purpose of use by the Verein Board.

7. Report from the JFKS School Shop – Jacqui Bespolka on behalf of Kim Douglass (not present)

a. The school shop had successful sales figures during three events to start the school year: Verein Coffee Morning, Einschulung, and Info Abend. Total sales for these events were around €1.000.
